### **Section 2:** I declare that all sheep in this consignment:

- a) Comply with all current relevant legislation
- b) To the best of my knowledge, all lambs are under 12 months of age (i.e. no permanent incisor teeth have erupted through the gum) and Regional bonus NSL & OSL lambs are under 6 months of age (April to end September) and under 8 months of age between October & January.
- c) Have been born and bred in the UK and produced in accordance with all Red Tractor Beef and Lamb standards and Organic certification standards (as appropriate)
- d) Have resided on Red Tractor Beef and Lamb assured holdings for at least the last 60 days and have resided on the last holding for at least 30 days.
- e) The haulier used (if applicable) is a member of the Red Tractor or QMS Farm Assurance Haulier Scheme and the animals were fasted for at least 3 hours prior to loading
- f) None of the animals listed have been treated with critically important antibiotics as outlined in the Kepak antibiotic factsheet.
- g) All animals comply with the Kepak Red Meat 'clean livestock policy'. I understand that any dirty animals may be clipped at my own expense

# **Section 3:** Compulsory Food Chain Information

Sheep and goats on this holding are NOT under movement restrictions for any animal disease or public health reasons (excluding a 6-day standstill). Withdrawal periods have been observed for all veterinary medicines and other treatments administered to the animals whilst on this holding and previous holdings. A note of any treatments, including medicated feed administered in the last 28 days is attached on a separate sheet see below.

To the best of my knowledge none of the lambs in this consignment are cloned or 1st generation progeny of cloned animals, nor are they suffering from any disease or condition that may affect the safety of the meat derived from them. No analysis of samples taken from these animals or other animals on the holding has shown that the animals in this consignment have been exposed to any disease or condition that may affect the safety of meat or to substances likely to result in residues in meat.
